Construction Status

On April 5th, a project walk through was held with Stu Farwell of the Los Altos Hills County Fire District (LAHCFD) and Kurt Wurnitsch of Pakpour Consulting Group (PCG) to review the project and prepare the final punch list items. The project was deemed substantially complete (see attached letter and completed punch list) and in conformance with the plans and specifications on April 9th.

The original contract amount was \$220,702.00. The adjusted final contract amount, including all change orders and deductions for bid items not constructed, is \$206,618.48.

As of April 16th all work, including punch-list items have been completed in accordance with the Contract Documents and all fire hydrants are in service. All vendors and subcontractors have been paid and all work was completed satisfactorily. The last day of work on this project was April 27, 2012 to adjust one (1) hydrant valve cover to grade for Bid Item No. 23 at the intersection of Voscaino Road/ Viscaino Drive. Therefore, we recommend acceptance of the project by the LAHCFD and filing a Notice of Completion (NOC) with Santa Clara County.

Change Order No. 2

Change Order No. 2 includes the following: (Please see Change Order No. 2 for a complete description.)

- Replacing a hydrant valve box cover for Bid Item No. 7.
- Credit for reduced scope of work for Bid Item No. 21.
- Replacing 3LF of concrete curb for Bid Item No. 38.
- Adjusting fire hydrant valve box to grade for Bid Item No. 23.

Balancing Change Order No. 1

Enclosed please find the final balancing change order in the sum of <\$20,658.00> for a deduction of material not used as part of this project. The balancing change order adjusts the original contract bid quantities to reflect the actually constructed quantities.

Purissima Hills Water District Reimbursement

Enclosed please find the memorandum dated April 23, 2012 addressed to Purissima Hills Water District (PHWD) requesting reimbursement of **\$1,830.00** for additional labor and materials associated with removing an old abandoned 1-inch service line located on the existing fire hydrant lateral for Bid Item No. 34 26347/ 26351 Esperanza Drive. The PHWD General Manager has agreed to reimburse the Fire District the full amount.

Repair of Two (2) Potholes fronting 26110 Eucalyptus Lane (Private Street) Update

On May 1, 2012, a second follow-up meeting was held between Ms. Janice Lisbonne (Property Owner at 26110 Eucalyptus Lane), her remodeling contractor (De Mattei Construction, Inc. (DMCI)) and the District Inspector, Mr. Kurt Wurnitsch. Ms. Lisbonne provided a copy of the cost proposal estimate obtained by DMCI. The cost estimate identifies \$1,800.00 for 220 square feet of street repair (see attached copy of cost proposal prepared by K&M Asphalt dated 4/30/12). After further discussions the Fire District has agreed to pay 70% (\$1,260.00) of the total \$1,800.00 repair cost. Ms. Lisbonne is currently reviewing a draft copy of the settlement agreement. The District Inspector anticipates bringing closure to the pothole repair settlement agreement in the next two of weeks.

Project Schedule and Request for Progress Payment No. 3

Enclosed please find Progress Payment No. 3 due WVC for this period for *\$1,148.55* (value of work minus 5 percent retention). The work performed to date has been satisfactory and payment is recommended.

After the 30-day lien period following the filling of the NOC to the County, we recommend releasing the remaining retention amount to finalize the last payment of the project. The total amount retained for this project is \$10,330.92.

As a result, nuisance storm water runoff tends to pond at the hydrant valve box cover. Raising the valve box cover and repaving a small area of the roadway shoulder was necessary to match the adjacent finished grade and provide positive drainage to reduce the amount of surface runoff trapped at the hydrant valve box.

On April 20th WVC provided a quote for a paving crew to adjust the hydrant valve box cover to grade, repave the depressed area of the roadway shoulder, and install 8LF of AC curb. On April 20th WVC was authorized to adjust the hydrant valve box cover to grade, repave the roadway shoulder, and install AC curb.

As previously discussed with Kurt Wurnitsch, Fire District Inspector during the course of construction for Phase III of the Fire Hydrant Replacement Project the LAHCFD is submitting the following items for reimbursement from the PHWD. These items were removed and/or installed by the Fire District's contractor, West Valley Construction, Inc. (WVC), as part of the Phase III project for the benefit of PHWD's water main distribution system.

Item No. 1A – Bid Item No. 34 (Fire Hydrant No. 6.56; 26347/ 26351 Esperanza Drive)

On March 2, 2012 WVC replaced the existing dry-barrel fire hydrant and bury with a new fire hydrant head, break-off spool/check-valve, and bury. On March 5th, while restoring water service to the new fire hydrant, WVC confirmed that there was a leak near the base of the new fire hydrant head.

On March 6th WVC was authorized by Time & Material/ Force Account to expose the leak, which was determined to be an old abandoned 1-inch copper service line for 26351 Esperanza Drive that was originally installed on the 6-inch AC fire hydrant lateral and capped at the back of AC curb. WVC was authorized to install a temporary cap/ crimp on the service to reduce the leak while the new fire hydrant remained in service until the service could be abandoned at the fire hydrant lateral.
