Independent Contractor Agreement with Denise Gluhan

RECOMMENDATION:

Adopt Resolution 19-28 Confirming District President's Authorization for and Vice Presidents Execution of Independent Contractor Agreement for Consulting Services for Emergency Services Management with Denise Gluhan

BACKGROUND

From April through June 30, 2019, Captain Denise Gluhan (Ret.) (Captain Gluhan) provided services as the Emergency Services Coordinator to the Los Altos Hills County Fire District (District) as a contract employee of the Santa Clara County Fire Department (Fire). The District reimbursed Fire for her time and wages.

As of July 1, Captain Gluhan is no longer employed by Fire. In order for Captain Gluhan to continue emergency services management for the District, it was determined that Captain Gluhan could be hired as a District part time independent contractor from July 1 through July 30, 2019. This is the period of time Captain Gluhan would be providing services in between July 1, 2019 and the July 30, 2019 Commission meeting.

DISCUSSION

The hiring plan was reviewed by District legal counsels. The hiring plan is a similar process used to retain Cori Vargas and Angela Nguyen as independent contractors which was necessary in between Board meetings.

At the Commission meeting on July 30, the Board of Commissioners will be asked to:

- 1. Confirm President authorization for and Vice President's execution of the Independent Contractor Agreement between Denise Gluhan and the District for services rendered from July 1 through July 30, 2019
- 2. Confirm Board President's authority for emergency expenditures to pay Captain Gluhan for services rendered from July 1 through July 30 in accordance with the Independent Contractor Agreement
- 3. Adopt Resolution 19-29 authorizing execution of an employment agreement with Captain Gluhan as a regular part time Emergency Services Manager for the District. Funding for the position is in the adopted 2019/2020 District budget.

The Personnel subcommittee, President Warren and Commissioner Spreen, were advised of the hiring plan, have reviewed the Independent Contractor Agreement and the Employment Agreement between the District and Captain Gluhan and are in support of these actions.
