CORONAVIRUS DISEASE (COVID-19) ADVISORY NOTICE

The Health Officer of the County of Santa Clara has ordered all individuals living

The Health Officer of the County of Santa Clara has ordered all individuals living in the County to shelter at their place of residence with limited exceptions. Government agencies are to cease non-essential gatherings and operations at physical locations. This meeting of the Los Altos Hills County Fire District on March 17, 2020 is an Essential Government Function and is therefore an essential gathering that has not been cancelled. The public may still attend the meeting in person, however the District is asking members of the public to consider the following preventive measures recommended by the Health Officer when deciding whether to attend this meeting.

- The Health Officer has declared that gatherings pose a heightened risk of COVID-19 transmission, and that older adults and individuals with existing health conditions as identified by the CDC are at particularly serious risk if they contract COVID-19 and should not attend.
- Avoid shaking hands.
- Avoid touching your face, eyes, nose, or mouth with your unwashed hands.
- Social distancing—staying at least 6 feet away from all other people—should be attempted where possible.
- Cover your cough and sneeze.
- If you are not feeling well or are experiencing cold, flu, or other symptoms, stay home.

Teleconference Participation: This meeting will be conducted in compliance with the Governors Executive Order N-25-20 issued on March 12, 2020 allowing for deviation of teleconference rules required by the Brown Act. Members of the Commission, members of Staff and Participants in the Special Meeting will be participating by teleconference. The purpose of this is to provide the safest environment for officials, staff and the public while allowing for public participation.
