**RESOLUTION OF THE LOS ALTOS HILLS COUNTY FIRE DISTRICT
BOARD OF COMMISSIONERS
DECLARING WEEDS OR BRUSH GROWING AND/OR RUBBISH
CONTAINED ON CERTAIN DESCRIBED PROPERTIES TO BE A PUBLIC
NUISANCE AND POTENTIAL FIRE HAZARD AND SETTING HEARING FOR
OBJECTIONS**

WHEREAS, weeds and brush growing within the Los Altos Hills County Fire District ("District") and rubbish contained upon certain streets, sidewalks, highways, roads and private property may be injurious to the health of the community due to increased fire hazard risk; and

WHEREAS, said weeds, brush and rubbish may constitute a public nuisance; and

WHEREAS, the District is authorized by Health and Safety Code Section 13879 to abate hazardous weeds and rubbish pursuant to Health and Safety Code Section 14875 et seq.

NOW, THEREFORE, the Board of Commissioners of the Los Altos Hills County Fire District does hereby RESOLVE as follows:

1. Weeds, brush and/or rubbish that create a fire hazard and or health hazard to the community constitute a public nuisance.
2. Said public nuisance exists or shall recur upon all the streets, sidewalks, highways, roads and private property, more particularly described by common name or by reference to the tract, block, lot, code area, or parcel number on the report by the Santa Clara County Agricultural Commissioner, that is attached to this Resolution as Exhibit A.
3. Said nuisance must be abated throughout the year by removal of said weeds, brush and rubbish; otherwise such materials shall be removed by the District and such cost shall attach to the Property and shall constitute a lien upon the responsible property until paid.
4. It is ordered that Tuesday, the 18th of January, 2022, at the hour of 7:00 p.m. is hereby fixed as the time and place when objections to the proposed destruction or removal of weeds, brush and/or rubbish shall be heard and given due consideration. The meeting will be held via Zoom Platform videoconference and can be accessed from PC, Mac, Linux, iOS, or Android at <https://lahcfd-org.zoom.us/j/82061022148> and entering password 420105; or via teleconference by calling (602) 333-2017 or (888) 204-5987 (US Toll Free) and entering access code 822528#.

5. The County Agricultural Commissioner is hereby designated as the person to cause notice of the adoption of this resolution to be given in the manner and form provided in the Health and Safety Code Section 14890 et seq., and the Uniform Fire Code Appendix II. A., and as the person to hereafter cause abatement of such seasonal and recurring nuisance.

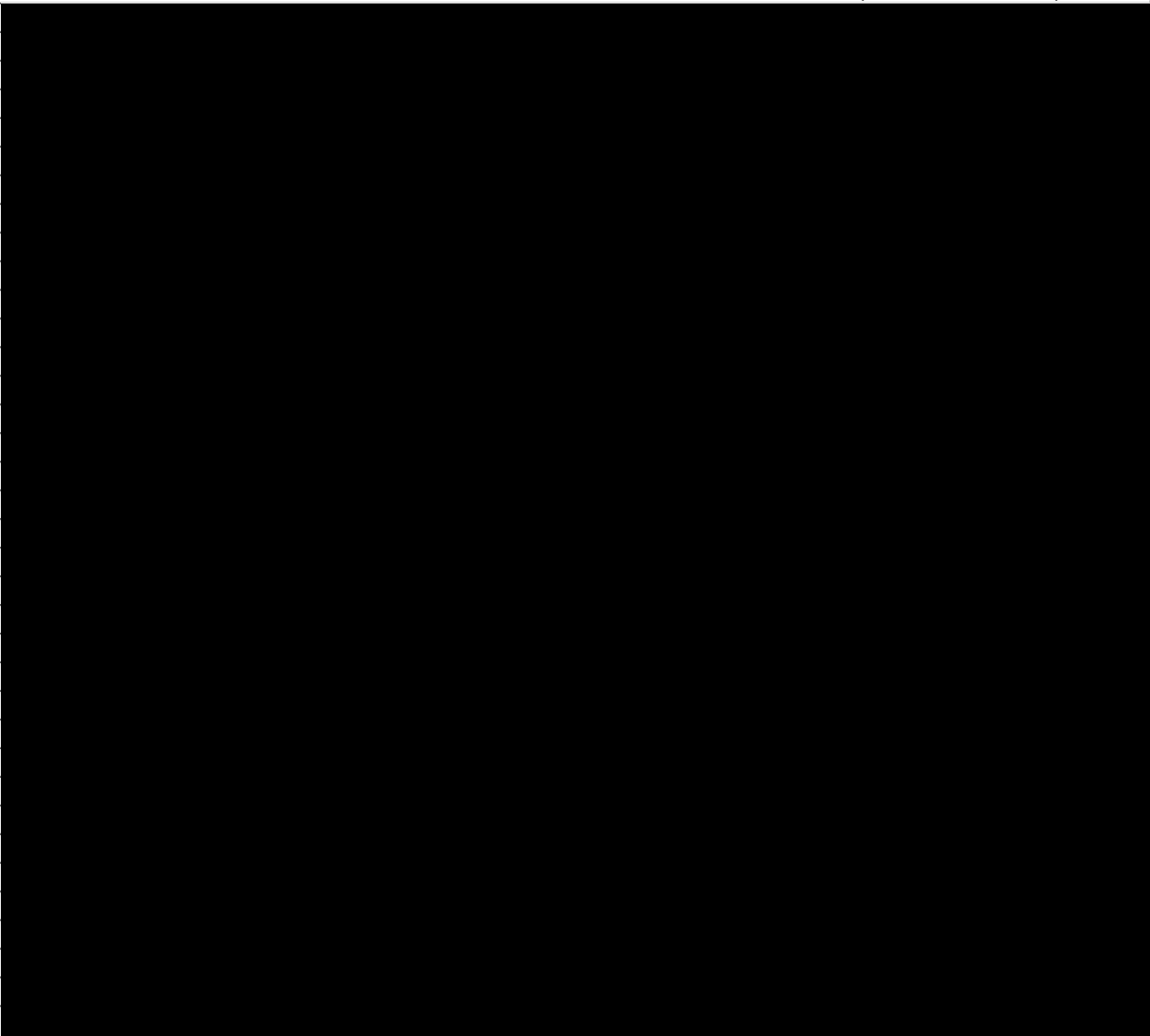
