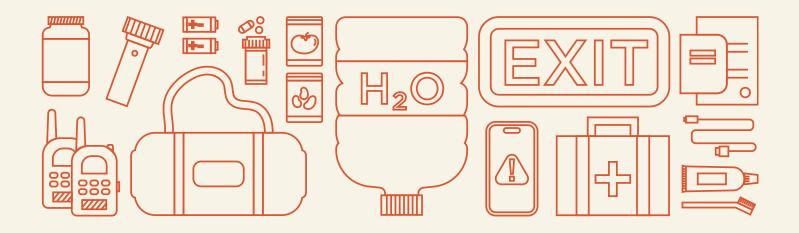

4 Key Steps for Emergency Preparedness

Emergency preparedness is important for keeping yourself, your family, and your community safe. Here are four simple but effective steps to ensure you're ready if disaster strikes:

emergencies.

Sign up for Alerts and Warnings
Ensure you're prepared for the next disaster by signing up for emergency notifications.
AlertSCC is the County's official emergency alert and warning system. Register at *alertscc.org* to receive emergency warnings on mobile devices, emails, or landlines.

Nixle is the Town of Los Altos Hills' emergency notification system, providing residents with timely updates on both emergency and non-emergency situations. Register at *bit.ly/nixleLAH* or text your zip code to 888777.

Pack a Go Bag and Stay Box
Disasters often strike without warning and escalate quickly, so it's important to be ready. Prepare a Go Bag with essential items in case you need to leave your home in a hurry.

In some situations, it may be safer to stay where you are. For those times, pack a **Stay Box** with supplies to help you shelter in place. Plan to have enough resources to last at least 5–7 days without water or electricity.

Identify at least two exit routes from your home and neighborhood in case of evacuation. Practice these routes with your family to ensure everyone knows how to safely and quickly leave in the event of a fire, flood, or other

Build a Resilient Neighborhood Network

Regularly check in with family members, friends, and neighbors — especially those who may need extra assistance, such as the elderly or individuals with disabilities. Coordinate plans to help them evacuate if needed and offer other ways to support them during an emergency. Discuss what you can contribute, such as radio communication, medical expertise, or backup power, to enhance neighborhood preparedness.

Refer to **pages 15–18** for preparedness checklists tailored for you, your family, and pets. These perforated cards are designed to be torn out and kept easily accessible in the event of an emergency or evacuation.



A Fire Weather Watch means critical fire weather conditions are possible. Be prepared.

A **Red Flag Warning** means elevated fire danger due to warm temperatures, very low humidity, and either sustained winds or frequent gusts of more than 25 mph.

Preparedness Tips:



Maintain defensible space around homes and buildings.



Remove dry leaves and debris from gutters, decks and around foundations.



Bring combustible outdoor furniture and decorations inside, or move them off the deck and away from the house.



Make sure your Go Bag is packed.



Keep an evacuation plan updated.



Ouring a Red Flag Warning:

- Close all house and car windows, even when you aren't inside.
- Move flammable materials, such as outdoor cushions, inside your home or garage.
- Remove dead shrubbery around your house.
- Monitor alert systems for up-to-date information regarding evacuation plans.
- Remain vigilant about your surroundings.

X Avoid:

- Backyard fires or using burn barrels
- Using powered equipment that creates sparks
- Parking vehicles on dry grass
- Throwing cigarettes or matches out of a moving vehicle

Protect Your Home Using Defensible Space

Creating defensible space around your home is one of the most effective ways to protect your property from wildfires.

Clear hazardous brush, overgrown tree limbs, and flammable vegetation within 100 feet of your home.

For maximum protection, establish a "Safe Zone" a completely clear area within 5 feet of all structures, free from combustible materials.

Defensible Space Brush Chipping and Debris Removal Program

This monthly program is available to all District residents. Crews will chip your cut vegetation on-site, with the option to have the chips hauled away or left on your property. Sign up online or by mail at any time. The service runs during a two- to three-week window each month.

LAHCFD provides this program in partnership with the Santa Clara County FireSafe Council (SCCFSC), a nonprofit specializing in fire safety and vegetation mitigation.



In 2024, over 1,000 households participated in the Brush Chipping program and 71,286 cubic yards of hazardous brush were chipped.

This amount of material would fill 21 Olympic-sized swimming pools.

Defensible space

is the buffer between your structure and the surrounding area. Adequate defensible space acts as a barrier to slow or halt the progress of fire that may otherwise engulf your property. It also helps improve the safety of firefighters defending your home.

Monthly Vegetation Drop Off and Removal Program

District residents can drop off limbs, brush, and branches, which will be hauled away by GreenWaste Recovery. Residents should be prepared to offload their own materials into the drop-off containers.

Only brush and yard trimmings are accepted by this program.

To participate, residents must:

- Show valid photo I.D. with address or current garbage bill
- Accompany the firm hired to deliver the material on every trip

GreenWaste staff cannot unload materials from vehicles unless residents are physically unable to unload their own materials.



How Can You Improve Your Home Ignition Zone (HIZ)?

Wildfires can spread rapidly, but did you know that your home's surroundings play a major role in its risk of ignition? Research shows that a home's vulnerability depends on its condition and everything within 200 feet of its foundation — this area is known as the **Home Ignition Zone (HIZ)**. By taking proactive steps to reduce flammable materials within this zone, you can significantly increase its chances of survival.

Upgrade Your Property's Fire Resiliency

Start with an HIZ Assessment. Even small changes may improve your home's wildfire resilience. LAHCFD offers a free HIZ Assessment and Rebate Program to help residents create defensible space and harden their homes using the latest fire science.

The HIZ Assessment on-site evaluation pinpoints fire risks around your home. Additionally, through our HIZ Rebate Program, LAHCFD will match funds up to \$3,000 for eligible hazardous vegetation removal. Since residents can participate once per year, you can start now and continue removing vegetation annually.

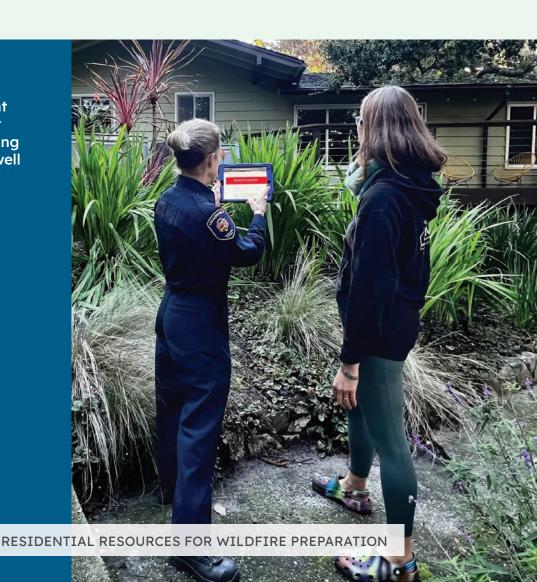

- Changing attic and crawl space vents
- Clearing gutters

Fire-Resistant Landscaping Tips

As wildfire seasons grow more intense, proactive landscaping is one of the best ways to safeguard your property. By following key fire-resistant practices, you can create defensible space and reduce the risk of fire damage to your home.

New Defensible Space Laws Coming in 2026

Starting in 2026, California will enforce stricter defensible space laws for homes in Wildland Urban Interface (WUI) areas:

Zone 0

0-5 feet from your home

This area must be clear of flammable vegetation, mulch, and dead plant material. This new law is designed to prevent fires from reaching your structure.

Defensible Space 100 feet around your home

Homeowners must maintain properly spaced trees and shrubs and remove

flammable vegetation to slow fire spread.



Maintain Your Landscape

Water and fertilize plants regularly and remove dry debris. During droughts, clear dead vegetation that could fuel fires.



Hydrate Strategically

A well-watered lawn can act as a natural firebreak.

Use drip irrigation to conserve water while keeping plants hydrated.



Prune and Space Wisely

Trim shrubs and trees to reduce dead material.

Maintain proper spacing:

- · Shrubs: Twice their height apart
- Trees: 10 feet apart
- Tree canopies: At least 10 feet from your home



Use Fire-Resistant Features

Patios, flowerbeds, and walkways can slow fire spread. Avoid bark mulch within 5 feet of your home, as it can ignite from embers.



Choose Fire-Resistant Plants

Opt for plants with high moisture content like succulents and live oaks. Avoid highly flammable species such as eucalyptus, rosemary, and lavender.



Use the District's monthly Defensible Space Services to reduce wildfire risk (see **page 7**).



Goats for Fire Fuel Reduction

Since 2006, LAHCFD has contracted goat services for fire fuel, or vegetation, reduction in challenging areas like the Byrne Preserve. This eco-friendly method reduces vegetation, creates fire breaks, and enhances wildlife habitats, all without toxic chemicals, noisy machinery, or environmental disruption.

Goats are especially effective in hard-to-reach areas, such as steep hillsides, wetlands, and stormwater zones.

They consume 4-to-10 pounds of vegetation daily (they'll even climb trees!) and excel at clearing plants like blackberry vines, thistles, nettles, and poison oak. Compared to alternatives like tractors or herbicides, goats provide thorough vegetation control with minimal impact.

LAHCFD continues to annually treat 9 acres of the Byrne Preserve using 500 goats to reduce grasses and brush.

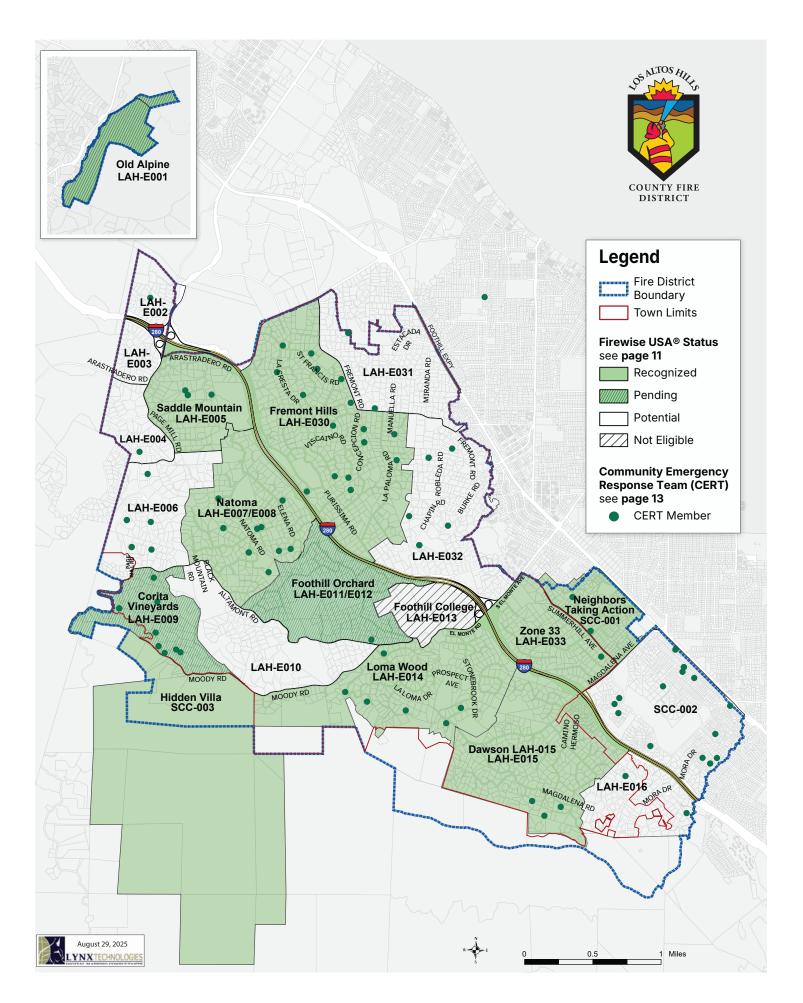

Clearing the Path to Safety Through Road Hardening

The District's Road Hardening, or Evacuation Route Program is designed to improve safety by removing flammable vegetation and roadside debris along key roadways, making them more accessible during emergencies and reducing wildfire risk. This process, known as road hardening, enhances evacuation routes and facilitates smoother travel for both emergency responders and the public.

Program Goals

- Clear Evacuation Routes: Ensure that roads remain passable during wildfires or disasters.
- **Improved Visibility:** Enhance travel safety for vehicles, pedestrians, and cyclists.
- **Reduce Fire Spread:** Limit the spread of wildfire along roadways and decrease the risk of roadside ignition.

Once a project is completed, the route is regularly monitored for the regrowth of hazardous vegetation or flashy fuels and maintained as needed to ensure long-term safety.

Regional Partnerships

The District works with Santa Clara County Fire Department, Caltrans, County Roads and Airports, the Town of Los Altos Hills, Santa Clara County FireSafe Council, and others to identify and prioritize high-risk areas. These partnerships allow for comprehensive, tailored vegetation management plans that address the unique needs of each route.

What Does a Safe Evacuation Route Look Like?

The District aims to create evacuation routes that are both fire-safe and visually appealing, maintaining the natural beauty of Los Altos Hills while enhancing safety. Strategic pruning improves visibility at intersections and along streets while preserving the shade canopy, thoughtfully balancing fire mitigation with the area's aesthetics, ensuring safer, more accessible evacuation routes.



The Cone Zone: Staying Safe in Roadside Work Areas

Evacuation route projects require traffic control measures, which are managed by a certified team. The District posts advance signage about upcoming projects. Cone Zones are marked by signs, cones, barriers, and work vehicles to protect both workers and drivers. Please do not drive, walk, ride, or cycle inside the cone zone or approach personnel.

Evacuation Checklist

This perforated card is designed to be torn out and kept easily accessible in the event of an emergency or evacuation.

Gather up flammable items from the exterior of the house and bring them inside (patio furniture, children's toys, doormats, trash cans, etc.) or place them in your pool.

 Shut all windows and doors. Remove flammable window shades and curtains and close metal shutters. Remove lightweight curtains. Move flammable furniture to the center of the room, away from windows and doors. Shut off gas at the meter; turn off pilot lights. Leave your lights on so firefighters can see your house under smoky conditions. Shut off the central heating/air
conditioning.
Animals Locate your pets and keep them nearby. Prepare farm animals for transport and think about moving them to a safe location early.

What to Wear

Wear protective clothing:

- Long sleeves and long pants (heavy cotton or wool)
- Avoid synthetic fabrics (they can melt and burn)

Shield your face and head:

- · Full-coverage goggles
- Natural fiber wide-brimmed hat (to block embers)
- Dry cotton bandana, wool scarf, or N95 respirator for smoke protection
- · Tie back long hair

Protect feet and hands:

- · Heavy-soled boots
- · Leather gloves

Bring essential lighting:

- Headlamp
- Flashlight (even during the day)

By navigating to *protect.genasys.com*, you can view a map of area evacuations and search for specific addresses to determine if they are affected by an order, warning, or other advisement.

California Standard Statewide Evacuation Terminology

Evacuation Order:

Immediate threat to life. This is a lawful order to leave now. The area is lawfully closed to public access.

Evacuation Warning:

Potential threat to life and/or property. Those who require additional time to evacuate, and those with pets and livestock should leave now.

Shelter in Place:

Go indoors. Shut and lock doors and windows. Prepare to self-sustain until further notice and/or contacted by emergency personnel for additional direction.

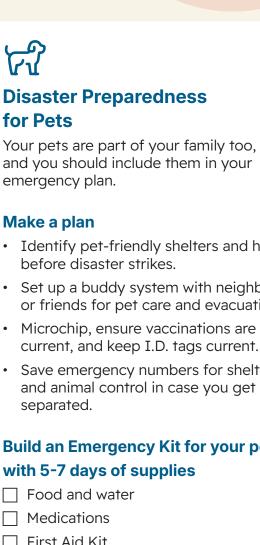

The following 2025 Evacuation Route projects are aimed at enhancing fire safety and ensuring clear, accessible evacuation routes for the community. This year's schedule encompasses more than 36 miles of strategic treatments, including maintenance and new projects to protect key routes throughout the District.

Commitment to Community Safety

Residents are encouraged to stay informed about these projects and watch for updates via mail. Residents along the project route can participate by granting the District Right of Entry. The District will provide regular updates and notifications as project dates approach.

Navigating the Right of Entry (ROE) Process

If your property borders an evacuation route project, you may be eligible to extend safety treatments onto your land by submitting a Right of Entry (ROE) form. This allows the District to assess and, if needed, trim vegetation beyond the standard 50-foot roadside treatment zone — enhancing both the evacuation route and your property's defensible space.

The ROE process provides flexibility — residents specify the level of vegetation treatment and approve the work before it occurs on their property. By participating, you help strengthen community wildfire resilience and improve overall evacuation safety.

How the Process Works

Before each project, property owners receive an informational packet by mail, including a ROE form.



District staff conduct on-site visits to discuss project details, answer questions, and review treatment options. If no one is home, staff will leave a doorhanger with project details.



Residents can contact the District to discuss treatment options, learn more about the project, or ask questions.

In the event of a wildfire or an emergency situation, law enforcement and fire agencies issue evacuation warnings or evacuation orders for impacted areas. In order to understand whether your area is under an evacuation warning or order, you need to know your Zone. Authorities use Zones in media releases and on social media to notify residents which areas are under an evacuation warning or order. Find your Zone now at protect.genasys.com

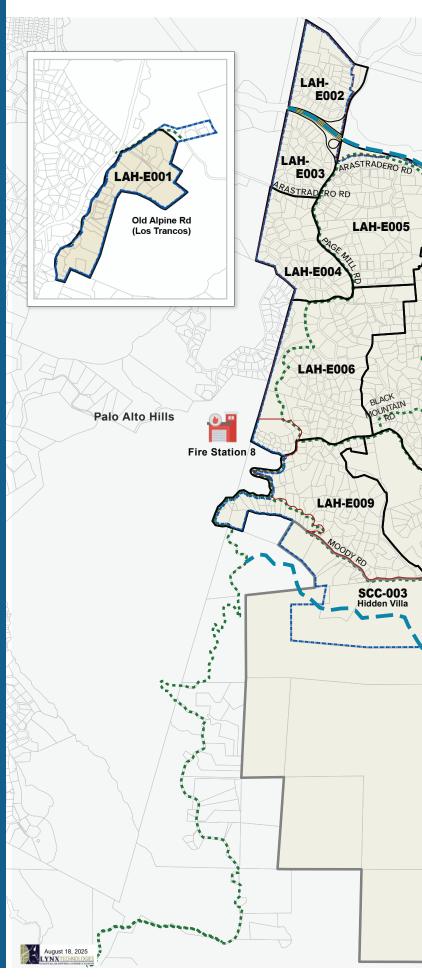


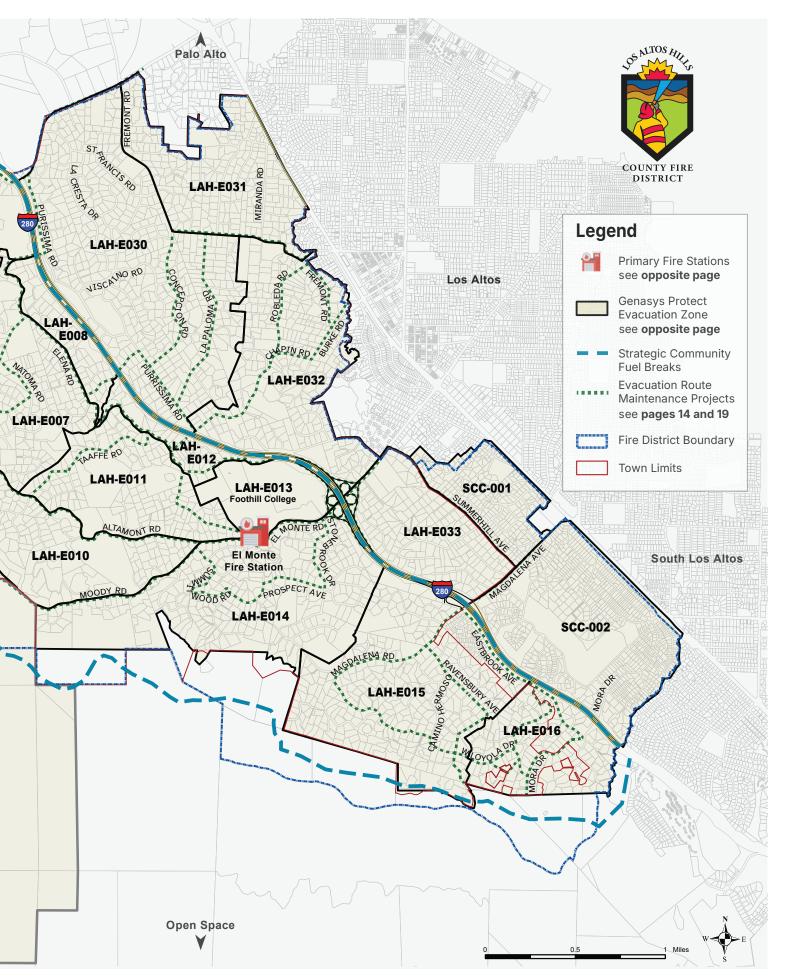
El Monte Fire Station

In 1996, the District built the El Monte Fire Station (Station 74), located on the Foothill College Campus. The District leases it to Santa Clara County Fire Department, which uses it for fire suppression and emergency medical services to District residents, the community, and via mutual aid.

Fire Station 8

LAHCFD funds the staffing of Fire Station 8, located in the City of Palo Alto, which provides protection to the areas of Los Altos Hills around Foothill Park and the surrounding communities during the high fire season, from mid-June to the end of October. The staffing of Fire Station 8 is in partnership with the Santa Clara County Fire Department and the City of Palo Alto Fire Department.





A Partnership to Protect the Community

As noted in the image, Los Altos Hills County Fire District (LAHCFD) focuses on wildfire and disaster preparedness, education, and risk reduction. Santa Clara County Fire Department (SCCFD) is a first responder agency that provides firefighting, fire suppression and emergency medical services when disasters occur.

LAHCFD and SCCFD collaborate closely to create a unified partnership to protect the community with programs to prevent and protect from fires and to build community preparation in the event of an emergency, wildfire or disaster.

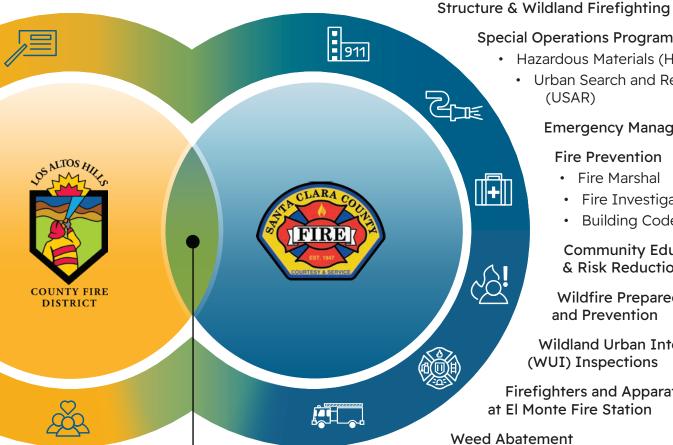

Countywide Wildfire Protection Partnerships

The Community Wildfire Protection Plan (CWPP) for Santa Clara County is a countywide guiding document that coordinates wildfire resilience efforts across multiple fire agencies, land managers, and cities.

Tailored Wildfire Planning

Given Santa Clara County's diverse landscape — ranging from urban and suburban areas to agricultural lands and nature preserves — a one-sizefits-all approach isn't feasible. To address local needs, annexes allow jurisdictions to implement customized wildfire management plans while benefiting from regional coordination and expertise.

LAHCFD Annex 4: A Targeted Approach

LAHCFD's Annex 4 builds on fire science, historical data, and risk modeling to develop programs and projects that reduce wildfire risk across its 12-square-mile district. Since wildfire knows no boundaries, regional collaboration is key to enhancing safety and supporting mutual aid during disasters.

Three Levels of Wildfire Risk Reduction



Individual or Parcel Level:

Homeowner education, Home Ignition Zone (HIZ) Assessment and Rebate Program, structural hardening, fire-resistant landscaping, and brush chipping removal/drop-off programs.



Neighborhood Level:

Support for Firewise USA Communities and roadside vegetation management to maintain safe evacuation routes.



District & Regional Level:

Development of **shaded fuel breaks** and participation in countywide fire mitigation projects.

Ongoing Innovation and Coordination

LAHCFD continuously integrates the latest fire science, vegetation management strategies, and legislative updates into its planning. The District actively collaborates on countywide wildfire preparedness efforts, including the Multi-Jurisdictional Hazard Mitigation Plan (MJHMP) and other key initiatives from agency partners.

Expected to be adopted by the County Board of Supervisors in 2025. the CWPP ensures regional connectivity and project tracking for more effective fire prevention strategies.

History of the District

Founded in 1939, the Los Altos Hills County Fire District (LAHCFD or District) is a dependent special district of the County of Santa Clara. LAHCFD serves residents of the Town of Los Altos Hills and unincorporated areas of Santa Clara County known as Loyola, Los Trancos, and San Antonio Hills and is governed by a sevenmember Board of Commissioners who live in the District. LAHCFD is approximately 12 square miles and has a population of approximately 12,229.

LAHCFD provides its residents with fire and disaster prevention and protection, while also building resiliency within the community. The District and the City of Los Altos (City) formerly operated a fire department. In 1996, the District and City decided to contract the fire department and emergency medical services with the Santa Clara County Fire Department, also known as the Santa Clara County Central Fire Protection District.

Hydrants & Appurtenance

LAHCFD owns, replaces, adds, and maintains 552 fire hydrants within its boundaries and the related infrastructures appurtenant to the hydrants from the water main. The infrastructure is connected to the Purissima Hills Water District (PHWD) water system.

An agreement between the County of Santa Clara Board of Supervisors and PHWD governs the terms and conditions of the duties and responsibilities of the parties. LAHCFD has a professional services agreement with a local engineering firm who serves as a consultant to the District on services, projects, and assistance to develop policies and processes for management of the District's hydrants and infrastructure for protection of property, life safety, and support of fire suppression systems.

Appurtenance refers to the accessories between the hydrant itself and the water delivery pipe — for example, valves.

About the Board of Commissioners

The seven-member LAHCFD Board of Commissioners is appointed by the District 5 Supervisor of the Santa Clara County Board of Supervisors, which is then approved by the County Board of Supervisors. Commissioners are residents of LAHCFD and serve a four-year term, with at least two of the Commissioners representing the unincorporated areas of the District.

The Board of Commissioners develops the District's Strategic Plan, budget priorities, and long-range planning documents to be used in the preparation of an annual operating budget based on a July through June fiscal year.

Fiscal Year 2025-2026 **Budget Overview**

The Fiscal Year 2025-2026 (FY25-26) Budget, adopted by the Santa Clara County Board of Supervisors and subsequently by the LAHCFD Board of Commissioners in June 2025, focuses on large-scale projects such as the I-280 Shaded Fuel Break Project (at a multi-year \$6M project cost), a newly proposed roadside weed mitigation program along District evacuation routes, and a feasibility study to build a new fire facility. The development of the Budget is also influenced by the recent wildfire events in Southern California.

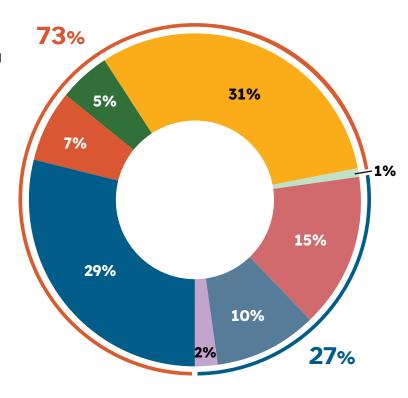

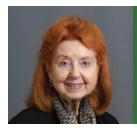
